


Membership

We continue to focus on growing a team of highly motivated communications professionals.

While membership declined in 2021, we began to see an increase in participation as professionals started going back to the office and mandates were lifted for in-person gatherings so we could move forward with how we do our work. In early 2022, we welcomed 13 new members to our family and we hope to attract new members with the continuation of in-person offerings and benefits. We value our CPRS-VI members and took care of them through 2021/2022 by offering free admission to all of our professional development events.

During Membership Month in March, we saw 20 new and renewing members. Over 25 percent of our current membership saw Membership Month as a valuable time to renew, especially with the \$50.00 discount and additional incentives like a chance to win a CPRS National Conference pass and a free one-year membership. As of March 2022, the CPRS-VI chapter held 78 memberships.

Our membership goals for the coming year include the organization of additional membership activities to open up opportunities for member involvement. To better understand our members' wants and needs, a membership survey was sent to lapsed members in February 2022 to help target future member benefits. Much of the feedback told us that there was a desire to re-introduce in-person events. As we continue into 2022, our goal for present and future members of CPRS-VI is to continue to show up for our members and support them in any way that we can.

Finances

CPRS-VI has \$110,518 in assets as of March 31, 2022.

- \$68,922 invested in endowed funds administered by the Victoria Foundation which supports CPRS-VI's annual grant and bursary program.
- \$28,956 in our strategic reserve. CPRS-VI maintains a three-month contingency and transfers any additional funds to our strategic reserve at the end of each fiscal year.
- \$10,183 in our operating account.

Our revenue sources include member dues, registration fees for events, and our career listing service.

CPRS-VI members receive career postings directly to their email inbox, providing them the first opportunity to share or access the opportunity. We also promote postings via social media and in our monthly e-newsletter. For the year ending March 31, 2022, we promoted 23 job opportunities, up from nine (9) the previous year.

We continue to use the services of a professional bookkeeper for operational efficiencies and as a financial control.

Awards

Financial Awards

We strategically invest in our membership, supporting the professional development of individual members. Our investments are managed by the Victoria Foundation and administered by the Communications and Public Relations Foundation. Since 2005, CPRS-VI investments have provided more than \$41,200 in grants and bursaries in support of members' learning and growth.

Greater Victoria Public Library Grant

CPRS-VI supports the Greater Victoria Public Library (GVPL) through an annual grant for the purchase of public relations books and reference materials. In 2021/22, CPRS-VI committed \$1,600 to GVPL for this purpose. As of March 31, 2022, CPRS-VI has made 14 grants to GVPL, totalling more than \$9,460.

National Conference Grant

We make a National Conference Grant available to assist members with the registration costs of the CPRS National Conference. In 2020-21, Shelley Termuende received a grant to attend the Cultivate national conference virtually. The selection process for the CPRS-VI National Conference Grant granting access to the 2022 national conference hosted in hybrid (virtual and inperson) format in Winnipeg, occurred past year-end. While the grant recipient(s) information is not yet available, that information will be available on the CPRS-VI website.

Denis Racine Bursary

This <u>annual bursary</u> was established in 2006 and was named in memory of Denis Racine, a former president of both CPRS-VI and the national society. In 2021, with the support of the Racine family, we changed the criteria so that any CPRS-VI member could apply. The annual \$1,000 bursary is available to CPRS-VI Members who live on Vancouver Island or the Gulf Islands, are registered in a communications-based, post-secondary educational program, and have completed three or more courses.

The decision for awarding the 2021/22 bursary was made after year-end but can be found on the CPRS-VI website.

Events and Engagement

Navigating the pandemic meant that our events remained virtual this year, but this did not dampen engagement and the opportunities to connect with one another for meaningful networking and professional development.

Staying virtual offered a unique opportunity to connect with CPRS members across Canada, as we actively promoted many great events offered by all Canadian CPRS chapters and even hosted a few of our CPRS Edmonton colleagues at our holiday mixer.

This year, the new Board decided to keep all CPRS-VI events free for members as a way of saying thank you to members for engaging with us and being part of our community. We are already planning some great in-person events for the rest of 2022 and look forward to catching up more in person.

Our Events

- Our June 2021 AGM- Learning Lessons of Pandemic Proportions- offered a fascinating glimpse into the early days of the pandemic with Chris Shewchuk, who helped lead the COVID-19 response in B.C., and his work with Dr. Bonnie Henry to connect with British Columbians during the pandemic (49 registrants).
- Our September Mixer was held online and provided a sense of community for communicators to connect and hear from everyone (25 registrants).
- In November, six members of CPRS-VI met approximately 20 Royal Roads University students in the Bachelor of Arts in Professional Communications program in a speed mentoring event. The session allowed mentors to share career advice, discuss industry trends and speak about the value of CPRS-VI membership.
- By far one of the highlights of our year was our Lunch and Learn held in November, Creating a Meaningful Land Acknowledgment, expertly facilitated by CPRS-VI Board member, Hannah Mashon. This lunchtime session helped participants get grounded and build their understanding of land acknowledgements and feel empowered to deliver an acknowledgement that is personal and authentic for our organizations (76 registrants).
- At our virtual Holiday Mixer: cocktails, candy canes and communicators, we hoisted a glass to one another and made cocktails online while playing some holiday trivia (20 registrants).
- Our March 2022 in-person mixer was the first in-person event of the year and a positive sign of things to come. We came together to connect, check in on each other, and have some laughs (15 registrants).

Certification

CPRS National offers three opportunities for practitioners to demonstrate their knowledge and recognize their accomplishments:

The Public Relations Knowledge Exam

In 2013, CPRS launched the Public Relations Knowledge (PRK) program, the first equivalence exam for the public relations and communications management professions.

To assess the foundation of public relations and communications management, establish a benchmark of knowledge, and establish a standard of excellence from which practitioners can build their careers, the PRK is well suited for post-secondary education graduates and junior practitioners.



Accreditation, Public Relations

CPRS offers the Accreditation, Public Relations (APR) voluntary certification program. Earning the APR designation demonstrates professionalism and is tangible evidence to the public that you have demonstrated a high level of knowledge, skills, and abilities in the area of public relations. It is for this reason that many organizations and corporations specifically seek public relations professionals with the APR designation.

We have a high proportion of APRs relative to our local membership. More than 20 per cent of CPRS-VI members hold accreditation.

At the time of publishing, successful APR candidates had not yet been publicly announced for the 2021/2022 year.

College of Fellows

Since 2000, the College of Fellows has acknowledged CPRS members who are proven leaders in the public relations and communications profession. To attain Fellowship status with CPRS, a public relations professional must be a member of the society for at least 10 years, have a minimum of 20 years of experience within the profession, and have the APR designation.

Successful Fellows have demonstrated a significant contribution to the public relations profession and CPRS. Successful Fellows devote their time and undertake tasks that advance the state of public relations in Canada, including mentoring others, speaking and writing about the value of effective public relations, or being involved in other College initiatives.


